Notice of competition for the awarding of two scholarships in memory of Federico Cafarella to students enrolled in the first year of the master's degree program in Corporate Finance at Luiss University in the 2024/2025 academic year

Thanks to the financial contribution of friends and the Cafarella family, Luiss University, announces a competition for the awarding of two scholarships in memory of **Federico Cafarella** earmarked for students enrolled in the first year of the master's degree program in Corporate Finance in the 2024/2025 academic year.

Federico was a Luiss student in the Economics and Business and Corporate Finance degree programs. During his university years, he always stood out in his studies, with his marked sense of irony and cheerfulness, achieving excellent academic results and showing empathy and closeness to all those who knew him. He left an indelible mark at Luiss by being a promoter of many initiatives related to the values he held most dear: meritocracy, friendship and dedication.

The two scholarships consist of a waiver of the second installment of the annual tuition fee, each one worth **4,400 euros**. The scholarships are not renewable for the second year of the degree program.

#### 1. Criteria for Awarding the Scholarships

The scholarships will automatically be awarded in July to the two students with the highest weighted average who:

- 1) were enrolled on track (*in corso*) in the final year of a bachelor's degree program at Luiss in the 2023/2024 academic year;
- 2) enrolled in the first year of the master's degree program in Corporate Finance by 22 April 2024;
- 3) have completed all of the examinations provided for in their study plan by the end of the 2024 summer examination session, with the exception of the final degree examination;
- 4) if admitted to an international mobility program, pay tuition fees and charges to Luiss for enrollment in the first year of the program.

In the event of a tie, the youngest student will be afforded priority.

The awarding of the tuition fee waivers will be communicated to the interested parties by July 2024. If an awardee is already the beneficiary of another scholarship, the waiver will be granted, again based on weighted average, to the next highest ranked eligible student.

## 2. Incompatibility

The aid envisaged by this competition is incompatible with other tuition fee waivers or scholarships held for any reason whatsoever, except for those awarded by Italian or foreign institutions designed to support, through periods abroad, a student's education for the academic years covered by this competition.

### 3. Revocation

The scholarship will be revoked upon the occurrence of any one of the following:

- the student fails to complete enrollment in the first year of the master's degree program in Corporate Finance for the 2024/2025 academic year at Luiss University;
- the student discontinues his or her studies;
- the student transfers to another degree program or university.
