



Call for applications for Admission to Master's Degree Programmes for the 2025/2026 Academic Year – Direct Admission for Luiss Students

Students regularly enrolled at Luiss in their third year in the 2024/2025 academic year who will obtain their bachelor's degree by 13 November 2025, and all those who already hold a bachelor's degree awarded by Luiss, may be admitted to Luiss on-campus master's degree programmes.

1. Addresses and Eligibility

1.1. Addressees

This selection procedure is open to Luiss students enrolled in the third year of a Luiss bachelor's degree programme or already holding a bachelor's degree, irrespective of the bachelor's degree programme pursued, who meet the requirements set out below.

1.2. Eligibility

Direct admission to master's degree programmes for the 2025/2026 academic year is granted to the following students:

- students enrolled in the third year of a Luiss bachelor's degree programme who, irrespective of the bachelor's degree they are pursuing, will be graduating by the end of the fall session of the 2024/2025 academic year (13 November 2025) whose **weighted average grade, without rounding-off, for exams taken is equal to or higher than at least 26/30** as at the end of the winter official exams session for the 2024/2025 academic year (February 2025), with the exception of what is provided for below for the master's degree programmes in Corporate Finance and in Management;
- students who graduated from Luiss by the academic year 2023/2024 with a **weighted average grade, without rounding off and net of any bonuses, covering just the exams taken to conclude the bachelor's degree programme, equal to or higher than at least 26/30** wishing to enrol in a Luiss master's degree programme, with the exception of what is provided for below for the master's degree programmes in Corporate Finance and in Management;
- students enrolled in first-level master's programs at Luiss Schools whose **weighted average grade, without rounding up, for exams taken** as part of the master's program as of 28 February 2025, is **at least 26/30** wishing to enrol in a master's degree programme and meeting the [minimum curricular requirements](#), with the exception of what is provided for below for the master's degree programmes in Corporate Finance and in Management. Students fulfilling that average grade requirement must complete their first-level master's program by 13 November 2025 while maintaining the requirement in question.

Direct admission to the master's degree programmes in **Corporate Finance** and in **Management** for the 2025/2026 academic year is granted to the following students:

- students enrolled in the third year of a Luiss bachelor's degree programme who, irrespective of the bachelor's degree they are pursuing, will be graduating by the end of the fall session of the 2024/2025 academic year (13 November 2025) whose **weighted average grade,**

without rounding-off, for exams taken is equal to or higher than at least 28/30 as at the end of the winter official exams session for the 2024/2025 academic year (February 2025);

- students who graduated from Luiss by the academic year 2023/2024 with a **weighted average grade, without rounding off and net of any bonuses, covering just the exams taken to conclude the bachelor's degree programme, equal to or higher than at least 28/30**;
- students enrolled in first-level master's programs at Luiss Schools whose **weighted average grade, without rounding up, for exams taken** as part of the master's program as of 28 February 2025, is **at least 28/30** and who meet the [minimum curricular requirements](#). Students fulfilling that average grade requirement must complete their first-level master's program by 13 November 2025 while maintaining the requirement in question.

For enrolment in degree programmes/majors taught in English it is mandatory to have at least a B2 level of proficiency in that language. To that end, account will be taken of the last level (interim or final) recorded during the student's university studies by the University Language Centre and it will not be necessary to furnish any certificate to demonstrate that level. Students holding or who will hold a bachelor's degree whose programme was taught in English will automatically be assigned a presumed level of B2. Fulfilment of that language requirement will be verified at the time of finalising enrolment.

Students who do not meet the direct admission requirements set out above will have to take the Admission Test in order to be admitted to Luiss master's degree programmes for the 2025/2026 academic year, regardless of the grade obtained. 2. Submission of an Application for Admission

2.1. Procedure and Deadlines

Solely students who fulfil the requirements for direct admission may proceed to register to attend lectures, through the Web Self-Service platform commencing from the end of March 2025 and no later than the non-extendable deadline of 22 April 2025, by completing the registration process through uploading the required documents and paying the amount due of € 4,600, or € 5,100 for the master's degree programmes in Corporate Finance and in Management.

2.2. Indication of the Chosen Degree Programme

Via the Web Self-Service platform students must make a binding decision as regards the master's degree programme to which they wish to be admitted and complete the registration process by specifying the major, if any. The degree programme chosen cannot subsequently be changed.

3. Conditions of Admission and Registration for Attendance (*iscrizione alla frequenza*)

Students who fulfil the requirements for direct admission will be able proceed to register to attend lectures, through the Web Self-Service platform commencing from the end of March 2025 and by and no later than 22 April 2025, by completing the online procedure and paying the first instalment of the annual single tuition fee (**contributo unico**) amounting to € 4,600. For the master's degree programmes in Corporate Finance and in Management, the first instalment, due on 22 April 2025, amounts € 5,100. It is not necessary at this stage to pay either the regional student welfare tax (**tasce regionale per il diritto allo studio universitario**) and the relevant stamp duty (**bollo**).

Registration for attendance must be completed in all its phases by no later than 22 April 2025. Any request to register to attend lectures, to change the master's degree programme or major received after the deadlines specified in this Call for Applications will not be considered.

In light of the specified deadlines, students are requested to contact the Admissions Office at ammissione@luiss.it in good time should they require support. In case of simultaneous participation in a number of selection processes (other universities, scholarships, double degrees, etc.), the onus is on students themselves to check whether the various deadlines are compatible with the above.

Please note that registration for attendance will refer exclusively to the 2025/2026 academic year and the chosen degree programme and cannot be considered as valid for subsequent years or other programmes.

4. Finalisation of University Enrolment (*perfezionamento dell'immatricolazione*)

Solely students who, by the prescribed deadline, have successfully completed the registration for attendance process by paying the relevant instalment of the annual single tuition fee may complete their university enrolment as soon as they obtain their bachelor's degree or in any event **by the non-extendable deadline of 13 November 2025**. Any request to complete and/or regularise enrolment late cannot be accepted after that date.

Through accessing the Web Self-Service as soon as they have obtained their bachelor's degree and **no later than the non-extendable deadline of 13 November 2025**, students must:

1. fill out the application for university enrolment;

2. pay the regional student welfare tax and relevant stamp duty through a procedure set out on the Web Self-Service platform;
3. print out, sign and upload the university enrolment application form accompanied by all of the required documentation.

For the 2025/2026 academic year, the amount of the annual single tuition fee for enrolment in the first year of a master's degree program is € 13,600 payable in three instalments, with the exception of the master's degree programmes in Corporate Finance and in Management for which the annual single tuition fee is € 15,300 (the first instalment is due on 22 April 2025 while the second and third instalments are due respectively in November 2025 and February 2026).

Regarding any decision not to complete university enrolment, it should be noted that pursuant to Article 27 of Royal Decree No 1269/38 "a student who has registered for a year of a university course may not under any circumstances obtain a refund of the fees, surcharges and taxes paid". In this regard failure to obtain one's bachelor's degree by the deadline of 13 November 2025 is the sole ground that entitles a student to a refund of the first instalment of the single tuition fee paid at the time of registering for attendance.

Moreover, it must be borne in mind that university enrolment is subject to the prerequisite academic qualification meeting the requirements laid down by the Ministry of Universities and Research and the Ministry of Foreign Affairs for the 2025/2026 academic year regarding enrolment at Italian universities.

NB: In any event a student's university enrolment is subject to properly registering for attendance by the deadline laid down in this Call for Applications through payment of the first instalment of the annual single tuition fee. In addition, university enrolment will be considered complete only after payment of the regional student welfare tax and stamp duty, submission of the application for university enrolment, the awarding of a bachelor's degree in the 2024/2025 academic year – by 13 November 2025 – entitling its holder to enrol in master's degree programmes in Italy in compliance with the prescribed curricular and language requirements, and submission of the documentation required to assess the validity of that degree.

5. Financial Aid and Scholarships

Please note that admission does not entail the awarding of a scholarship. Admitted candidates may compete for scholarships on the basis of the calls for applications to be published by the Financial Aid Office [on the following page](#). Luiss scholarships consist of total or partial waiver of tuition fees, with no other aid envisaged (for example, monthly allowance, teaching materials, etc.).
