Regarding the deferral of the deadline established by the R.D. 1.8.2025 n. 242 - Call for Applications for Admission to the Honor Course "Mediterranean Futures: Addressing Global Challenges" as part of the First Edition of the Arab-Mediterranean Campus Project (Academic Year 2025/2026)

#### THE RECTOR

- Considering D.D. No. 377 of October 13, 2022, by which the Ministry of University and Research published the Public Notice for the submission of project proposals for the "Progetto di rilevante interesse internazionale Legacy Expo 2020 Dubai" in the implementation of the Interministerial Decree No. 937 of August 4, 2022 (hereinafter also referred to as the 'Notice');
- Considering that Luiss, in response to the aforementioned Notice, submitted a project proposal application with the project code "expo2020dubai-00011", title "CAM – Campus Arabo Mediterraneo", type of intervention a) "Campus Arabo-Mediterraneo" as the proposing entity;
- Considering that the aforementioned application was submitted in partnership with the following co-proposing institutions: University of Naples 'Federico II', Ca' Foscari University of Venice, Catholic University of the Sacred Heart, Politecnico di Milano, University of Bari Aldo Moro, University of Bologna, University of Modena and Reggio Emilia, University of Parma, University of Ferrara, University of Milano-Bicocca, and University of Milan;
- Considering the Decree approving the final ranking list of eligible and fundable projects, D.D. No. 237 of December 27, 2023, as amended by D.D. No. 88 of March 28, 2024;
- Considering the Director's Decree of funding award No. 197 dated June 27, 2024;
- Considering that, through an innovative teaching approach which combines online and in-person learning, the project will equip young students and professionals from both the private and public sectors—originating from the areas covered by the project—with the skills and competencies needed to navigate a rapidly evolving labor market, both in the MENA region and internationally, and that the educational component of the project is structured as follows:

- Online and in-person “Honor” courses for undergraduate students from MENA universities, featuring one week of in-person learning in Rome and one week at another Italian partner university. Each in-person module includes half classroom-based teaching and half study visits to institutions, companies, organizations, or public bodies. A total of 5 editions will be implemented over 5 years.
- Online and in-person “Executive” courses for professionals from MENA institutions and organizations, featuring one week of in-person learning in Rome and one week at another Italian partner university. Each in-person module includes half classroom-based teaching and half study visits to institutions, companies, organizations, or public bodies. A total of 5 editions will be implemented over 5 years.
- Considering the outcome of the consultations carried out by the Scientific Coordinator of the Arab-Mediterranean Campus Project and representatives of partner universities in the MENA region;

## **DECREES**

### **ART.1 – DEFERRAL OF TERMS**

The deadline originally established by R.D. 1.8.2025 n. 242, for admission to the Honor Course “Mediterranean Futures: Addressing Global Challenges,” within the framework of the First Edition of the Arab-Mediterranean Campus project (academic year 2025/2026), has been deferred.

The new deadline for submitting applications is September 22, 2025, at 4:00 PM (CEST), UTC+2, instead of the original deadline of September 12, 2025.

### **ART.2 – ACTIVATION**

The Honor Program “Mediterranean Futures: Addressing Global Challenges” is hereby activated at Luiss Guido Carli for the academic year 2025/2026, as detailed in Article 2. The application and admission procedure for candidates to the course is hereby announced.

The program is organized in collaboration with the university consortium of the Arab-Mediterranean Campus, composed of the following Italian universities: Libera Università

Internazionale degli Studi Sociali Guido Carli, University of Naples “Federico II”, Ca’ Foscari University of Venice, Università Cattolica del Sacro Cuore, Politecnico di Milano, University of Bari “Aldo Moro”, University of Bologna, University of Modena and Reggio Emilia, University of Parma, University of Ferrara, University of Milano-Bicocca, and University of Milan (Statale). The consortium has been awarded funding for the project by the Italian Ministry of University and Research (MUR), through Director’s Decree of Award No. 197 dated 27/06/2024.

## **ART. 3 – PROGRAMME FEATURES AND TEACHING ORGANISATION**

The program addresses the future of the Mediterranean from different perspectives: entrepreneurship, environmental sustainability, artificial intelligence, innovative agriculture, circular economy, space economy and social innovation.

The program aims to provide students with an interdisciplinary background on the main transformations affecting the Mediterranean area, with a focus on the global dimension of contemporary challenges.

The course is aimed at students enrolled in undergraduate degree programs (Bachelor's or B.Sc. or equivalent) at universities in the MENA region (Middle East & North Africa) and provides multidisciplinary training in English, divided into thematic modules, online and in-presence activities.

The program consists of two phases and is aimed at 100 university students from universities in the MENA region. The first phase of the program includes 40 hours of asynchronous online training; upon completion of the training, the best 50 students will be selected to take part in the second phase of the program. The second phase of the program includes 60 hours of training to be carried out over two weeks in Italy: the first week will take place at the Luiss Guido Carli University in Rome and the second week at the University of Naples Federico II.

Course commencement: starting from the second half of October 2025

Duration: 40 hours online + 60 hours face-to-face in Italy

Course language: English

Course organization: students who have completed the hours of online attendance in asynchronous mode will be able to access the final multiple-choice course evaluation. The best 50 students in the course, identified based on their score in the final assessment, will be able to access the 60 hours of in-person teaching in Italy.

## **ART. 4 ADMISSION REQUIREMENTS**

Candidates wishing to apply for the selection process referred to in Article 1 must meet the following minimum mandatory requirements:

- Be regularly enrolled in the final year of an undergraduate degree program (Bachelor's degree, B.Sc., or equivalent to a three-year Bachelor's degree in Italy) at a university located in one of the countries of the MENA region (Middle East and North Africa). The countries included in the MENA region are: Algeria, Saudi Arabia, Bahrain, Djibouti, United Arab Emirates, Egypt, Jordan, Iran, Iraq, Israel, Lebanon, Libya, Morocco, Oman, Palestine, Qatar, Syria, Somalia, Tunisia, Turkey.
- English language proficiency at a minimum of B2 level (Upper Intermediate) according to the CEFR, verified by an official certificate issued within the last three years;

Additionally, candidates are required to submit the following documentation:

- Valid ID card or passport
- Official transcript of records issued by the home university, bearing an official stamp, listing all completed exams. The transcript must include the official indication of the weighted average grade. The document must be provided in English
- Curriculum Vitae (CV)

## **ART. 5 - SELECTION PROCEDURE**

The selection procedure for admission to the Course consists of three stages:

Phase 1: In this phase, the possession of the minimum mandatory requirements will be verified, namely being enrolled in the final year of an undergraduate university program (Bachelor's degree, B.Sc., or equivalent to a three-year Bachelor's degree in Italy) and holding a certificate proving English language proficiency at a minimum B2 level of the CEFR (Upper Intermediate). Candidates who do not meet these requirements at the time of application will not be admitted to Phase 2 of the evaluation.

Phase 2: In this phase, the transcript of records, the average exam grades, and the CV will be evaluated in collaboration with the partner universities located in the MENA region and the University of Naples Federico II. Candidates who achieve a minimum score of 36 points will be admitted to Phase 3.

Phase 3: This phase consists of a brief interview to assess the candidate's aptitude and motivation for the course. Candidates will be considered successful in the interview process if they achieve a minimum score of 24 points.

Candidates who achieve a minimum overall eligibility score of 60 points—calculated as the sum of the scores obtained in the two evaluation phases, with at least the minimum required score in each phase—will be admitted to the course.

The final ranking will be determined based on the total score achieved across the three phases. Geographic balance—aligned with the project's objectives—will also be considered, following a criterion of proportionality with respect to the number of applications received from each country.

In cases where candidates obtain the same overall score, and in order to ensure both gender balance and representation from all MENA countries involved in the project, the following criteria will be applied to determine the final admission ranking:

- Being enrolled in one of the least represented MENA countries, ensuring an appropriate geographic balance proportional to the number of applications received
- Belonging to the less represented gender
- Order of submission of the application for admission to the course

## **ART. 6 - RANKING AND ADMISSION**

The results of the selection process will be communicated to the candidates via email at the address provided on the application platform, and will also be published on the website at the following link: <https://mediterraneancampus.luiss.it/campus-arabo-mediterraneo-cam-honor-program/>

Admitted candidates must confirm their participation within 7 days from the day following the publication of the ranking on the AMC website (<https://mediterraneancampus.luiss.it/campus-arabo-mediterraneo-cam-honor-program/>) and the simultaneous admission notification sent to the candidate via email. Additionally, admitted candidates must submit or send by email, to [campus.am@luiss](mailto:campus.am@luiss), the enrollment application for the Course (to be completed using the specific form that will be sent to them via email) within the deadline indicated in the admission notification, along with the required attachments.

## **ART. 7 – APPLICATION FOR ADMISSION**

The application for participation in the call must be submitted exclusively online through the dedicated platform.

Candidates are responsible for the information they enter in the online application form and for the validity of the certifications/self-declarations they submit. The University reserves the right to verify the accuracy of the information and the validity of the documents provided. In cases of non-compliance with the declared information, candidates may be excluded from attending the course at any time, even after the admission process has been completed. Once the application

form has been completed, the candidate will receive a copy of the submitted application as confirmation that the procedure was successfully completed. The application shall be considered, for all legal purposes, as a self-declaration of the personal data and qualifications stated therein.

The deadline for submitting applications has been deferred to **September 22, 2025 at 4:00 PM (CEST), UTC+2.**

## **ART. 8- WITHDRAWAL**

Admitted participants who intend to withdraw from attending the Course are required to notify the Course Scientific Coordinator, Prof. Raffaele Marchetti, in writing by e-mail in order to allow access to any candidates on the waiting list. Enrolled participants may only submit their request to withdraw before the start of the lessons.

## **ART. 9 - OBLIGATIONS OF ENROLLED PARTICIPANTS**

All participants enrolled in the Course are required to fulfill the academic commitments undertaken upon enrollment. They must also behave in a manner that supports the effective conduct of educational activities and the proper administration of assessments, while respecting personal integrity, the dignity of others, the decorum of the learning environment and, more generally, university life.

Any violation of the above-mentioned behavioral obligations may result in disciplinary action, without prejudice to any additional legal sanctions.

Attendance is mandatory, and participants must strictly adhere to the class schedule. Enrolled participants are also required to comply with attendance monitoring procedures as established. To be eligible to sit the final assessments, participants must have attended at least 80% of the total class hours scheduled in the program.

## **ART. 10 – CERTIFICATIONS**

Participants who successfully complete the entire program will be awarded a certificate of attendance and/or a certificate of successful completion of the course.

## **ART. 11 - PERSONAL DATA PROTECTION**

Luiss treats the personal data of candidates in full conformance of Reg. UE/2016/679 exclusively for administrative purposes related to this call for applications.

Luiss, as Controller, collects and processes the identifying data (name, surname, place and date of birth, personal tax number and citizenship), contact data (residential address, e-mail address and telephone number), data relating to academic record, data relating to knowledge of foreign languages, data relating to any certifications held by the data subject, in order to manage the application for participation in the competition and related obligations (the legal basis for processing lies the fulfillment of the pre-contractual obligations between the parties).
