

Announcement for the awarding of one Associate Professor pursuant to article 18, paragraph 1, of Law No. 240 of December 30, 2010, for the 13/ECON-06 - Business Administration, Accounting & Performance Measurement academic-discipline group in the ECON-06/A - Business Administration, Accounting & Performance Measurement academic-discipline field at the Department of Accounting and Corporate Finance at Luiss Libera Università Internazionale degli Studi Sociali Guido Carli – vacancy code DACF-ASSOC-12/2026

The Rector of Luiss Libera Università Internazionale degli Studi Sociali Guido Carli:

- Having regard to article 18 of Law No. 240 of December 30, 2010;
- Having regard to the current Independence Statute of Luiss Guido Carli;
- Having regard to the current University General Regulations;
- Having regard to the current Code of Ethics of Luiss Guido Carli;
- Having regard to the [Regulations on the procedures for the recruitment of first-level and second-level professors at Luiss University \(in implementation of Articles 7, 18 and 24 of Law No 240 of 30 December 2010 and Articles 1\(9\) and 1\(12\) of Law No 230 of 4 November 2005\), in force;](#)
- Having regard to the resolution of the Board of Directors of Luiss University of 12 December 2024 approving the University's 2025-2028 strategic plan;
- Having regard to the proposal of June 30, 2026, of the Board of the Department of Accounting and Corporate Finance, having consulted with the Academic Senate through the Rector, designed to provide for teaching and research activities in the 13/ECON-06 - Business Administration, Accounting & Performance Measurement academic-discipline group in the ECON-06/A - Business Administration, Accounting & Performance Measurement academic-discipline field at the Department of Accounting and Corporate Finance;
- Having regard to the resolution of the Executive Committee of July 22, 2026,

RESOLVES

Article 1

Announcement

Luiss Libera Università Internazionale degli Studi Sociali Guido Carli (hereinafter the “University” or “Luiss Guido Carli”) hereby announces – pursuant to article 18, paragraph 1, of Law No. 240 of December 30, 2010, and in the manner laid down in the Luiss Guido Carli regulations governing the procedure for recruiting first and second level professors at Luiss Guido Carli pursuant to articles 18 and 24 of Law No. 240 of December 30, 2010, in force (hereinafter the “Regulations”) – a selection procedure for the recruitment of a tenured professor with the following characteristics:

- Number of positions: one;
- Associate Professor;
- Department of Accounting and Corporate Finance;
- Academic-discipline group (**GSD**) 13/ECON-06 - Business Administration, Accounting & Performance Measurement;
- Academic-discipline field (**SSD**) ECON-06/A - Business Administration, Accounting & Performance Measurement;
- Competition code (**codice concorso**) DACF-ASSOC-12/2026;
- Specific functions: the successful candidate will be assigned to the Department of Accounting and Corporate Finance Luiss. The selected professor will undertake teaching and research duties in harmony with the belonging academic discipline field and with the main research lines of the University, its Research Centers, and the Schools, on themes of Financial Reporting and International Accounting Standards, Financial Statement Analysis and Equity Valuation, and Corporate Governance. He/She will have to be able to teach in Italian and/or in English. Teaching activities, supplementary teaching activities, and student support services shall amount to 350 hours per year, including 120 hours per year dedicated to classroom teaching in the case of a full-time commitment regime, or 250 hours per year, including 90 hours per year dedicated to classroom teaching in the case of a defined-time (part-time) commitment regime. The teaching activity will be carried out as part of the planning of undergraduate, single-cycle and graduate's degree courses of the University, and will consist in carrying out lectures, exercises and theoretical-practical activities, assistance during exams, in any teaching assignments assigned as an institutional task, according to the provisions and within the limits of the law. The teaching activity will be carried out with reference to the academic-discipline field namely ECON-06/A Business Administration, Accounting & Performance Measurement. Specific topics and functions are:
 - Financial Reporting and International Accounting Standards;
 - Financial Analysis and Equity Valuation;
 - Corporate Governance.
- The remuneration that the winner of the selection will be entitled to under article 8 of Law No. 240/2010 and Presidential Decree No. 232 of 15 December 2011 is that applicable to Associate Professors depending on the career position of the winner and the relevant commitment chosen.

Article 2

Requisites for the Submission of Applications and Exclusions

The selection is open to:

- A. Candidates who have obtained national eligibility pursuant to article 16 of Law No. 240/2010 for the academic-discipline group and for the functions that the procedure concerns or for higher functions, provided that they do not already hold the same higher functions;
- B. Candidates who have obtained eligibility pursuant to Law No. 210/1998 for the level corresponding to that covered by this announcement subject to the duration of the eligibility;
- C. Professors already working at other universities at the level corresponding to that for which the selection is announced;

D. Italian or foreign scholars permanently involved abroad in research and teaching activities at university level in a position equal to that which this announcement concerns on the basis of the equivalence table set out in Ministerial Decree No. 456 of May 10, 2023.

The candidates should be able to teach courses and write journal articles also in English.

The qualifications must be held on the date that the competition closes.

The procedure for the awarding of the contract referred to in this announcement is not open to those who are related, by blood or marriage up to the fourth degree inclusive, to a first or second level professor at the Department in question, the Rector, the General Manager or a member of the University's Board of Directors.

Article 3

Applications

Applications to participate in the public selection procedure as well as qualifications held and documents and publications considered useful for the selection procedure must, on pain of exclusion, be submitted electronically using the dedicated computerized platform on the following page of the University's website: <https://pica.cineca.it/luiss/dacf-assoc-12-2026/domande/>

The platform will necessarily require candidates to have an e-mail address in order to be able to register automatically with the system. The candidate must enter all the required data to generate their application and attach soft copies of the documents referred to in this announcement. No other form of submitting applications or documentation with a view to participating in the selection will be accepted.

By the deadline for the submission of applications, the system allows candidates to save their application in draft mode. The date of electronic submission of the actual application for participation in the selection is certified by the computer system through a receipt that will automatically be sent by e-mail. Upon expiry of the deadline for submission, the system will no longer allow access to and submission of the electronic application form. Applications received after the deadline will not be accepted.

Each application will be assigned an identification number that, together with the competition code specified on the platform, will have to be specified in any subsequent correspondence.

The process for filling out and submitting applications must be completed no later than **2 p.m. Central European Summer Time (CEST), on 45th day** running from the day after the date of publication of the Notice regarding this announcement in the Official Journal of the Italian Republic - 4th special series. If the stated deadline falls on a public holiday, it is extended to the next business day.

The submission of the application must be formally completed by choosing one of methods of signature set out in the "digital signature" page of the dedicated platform.

The service may be temporarily suspended for technical reasons.

Should the computer systems adopted by the University suffer a proven technical glitch making submission of applications impossible through the platform, the University reserves the right to accept applications in ways other than that indicated in the previous paragraphs.

In their application, candidates will have to declare under their own responsibility:

- Department, academic-discipline group, academic-discipline field of the selection procedure;
- Surname and name;
- Gender;
- Place and date of birth;
- Residence;
- Nationality;
- Contact address for the purposes of the competition;
- Tax number (solely for Italian residents);
- E-mail address for the purposes of the competition;
- Telephone number;
- University qualifications held (degree, research doctorate);
- Fulfilment of the requisites referred to in article 2 above;
- Information concerning the enjoyment of civil and political rights in the applicant's country of citizenship, criminal convictions, and pending criminal proceedings;
- Information regarding military obligations;
- That they have not been removed from employment or relieved of my duties with an Italian public authority and neither have I forfeited an Italian government job on the grounds set forth in subparagraph d) of the first paragraph of article 127 of Law No. 3 of 10 January 1957;
- That they possess an adequate level of knowledge of the English language as required by the announcement;
- That the publications attached for evaluation have all been published or accepted for publication.

Candidates with a recognized disability, pursuant to Law No. 104 of 5 February 1992, must specify in their application the assistance that they will require having regard to their situation as well as the extra time, if any, needed for the interview.

The following must be attached to the application and uploaded to the system:

- A copy of a valid identification document;
- An academic-professional curriculum;
- The academic publications up to a maximum of 10 that candidates intend to rely on for the purposes of the selection procedure.

Each attachment must not exceed 30 megabytes.

Should the candidate submit more than 10 publications and/or works, the extra ones will be excluded from the comparative assessment.

Works published abroad must cite their ISBN or equivalent.

Publications may be submitted in their original language if that is Italian or English. Otherwise, they must be translated into one of those said languages. If the translations are not provided, the related publications will not be evaluated. The translation must be submitted along with a copy in the original language.

The Examining Commission shall have the sole say on checking and judging the admissibility of the application and attached documentation.

The official e-mail address of Luiss University for the purposes of this competition is recruiting@luiss.it, except as otherwise provided. The e-mail address stated in the application and the Luiss Guido Carli website constitute the official means of communication for this selection process and all related matters, except as otherwise provided. Therefore, the candidate is required to consult both communication channels. Luiss University assumes no liability for any inability to contact the candidate or for any correspondence that goes astray as a result of the candidate's giving of an imprecise e-mail address or any problems not attributable to the University itself or in any event attributable to third parties, chance or force majeure.

Article 4

Examining Commission and Selection Procedures

The Commission is appointed by the Department Council and made up of three professors in accordance with the provisions of article 6 of the Regulations.

Should a commission member be replaced during the course of the procedure, everything done up to the time of that replacement shall remain valid and effective pursuant to the principle of conservation of legal acts.

The Commission will appoint one of its number as the Chairperson and another as the Recording Secretary.

The comparative evaluation is informed by the principles of article 7 of the Regulations as supplemented and specified below.

The selected candidate must have carried out research activities at the national and international level, as demonstrated by:

- A commitment to significant academic research and scientific publications in high-quality international academic journals, as well as continuity of research during time, particularly over the last five years;
- Active participation in the international academic debate within the relevant scientific community, (including participation in international conferences, invited talks, and invitations to present research work in top tier universities);
Visiting scholarships or visiting professorships at prestigious schools, universities, and research institutions;
- Proven participation in the editorial boards of leading international journals and in the committees of relevant international conferences.

The selected candidate will be evaluated by taking into account teaching experiences, in both Italian and English, at undergraduate, graduate and post-graduate level, as well as the supervision of Bachelor's and Master's and phd's students, in subject consistent with the relevant scientific-disciplinary field and with the candidate's teaching and research activities. The comparative evaluation of scientific output will also take into account the relative standing of the journals and publishers recognized in the relevant scientific fields. The comparative evaluation of training or research activities at highly qualified Italian or foreign academic institutions will take into account the quality of positions held, and the relative contractual qualifications.

In addition to the candidate's academic prowess the evaluation will also take account of the linguistic skills necessary because of the University's multilingual character and the teaching needs for courses taught in foreign languages. To this end candidates might be called upon to hold a seminar on a topic of their choice, in English, also in presence of students. The Commission will summon candidates for the holding of the seminar subject to giving them at least 20 calendar days' notice.

The publication of the notice of convocation to the seminar on the Luiss Guido Carli website will have the value of notification for all participants in the competition, without the obligation of any further communication. Notice of the publication may also be given to the e-mail address indicated by the candidates in the application. Luiss Guido Carli assumes no responsibility for non-receipt or non-reading of the e-mail. It will, however, be the responsibility of the candidates to keep informed by consulting the website, in the section dedicated to the competition, to find the necessary information.

In case of absence from the seminar, the participant automatically renounces the comparative evaluation.

At the end of the proceedings the Commission will come to an overall judgment on each candidate and will compile a ranking to be sent to the Department Board.

Article 5

Duration of Selection Process

The Commission will conclude its work within four months after its appointment. The Rector may extend once and by two months at most the deadline for the conclusion of the procedure for stated reasons given by the Commission Chairperson.

Taking account of the Commission's judgment, teaching needs and the profile and functions specified in the announcement, the Department Board will establish, by reasoned and favourable vote of the absolute majority of first-level professors for the recruitment of first-level professors and absolute majority of first and second level professors for the recruitment of second-level professors, a ranking of names for submission to the Rector. On the basis of the deliberations of the Department Board, the Rector will make a proposal to the Executive Committee. The Executive Committee will decide on the recruitment. The Rector will issue a decree recruiting the professor.

Article 6

Protection of Personal Data

Luiss Guido Carli, as Controller, collects and processes data subjects' information in full compliance with the general principles and rules laid down by the law governing the protection of personal data (Legislative Decree No. 196/03 and Regulation (EU) No. 2016/679).
