



## **Call for Applications for Visiting Professors 2027/2028 Academic Year**

With the aim of continuously fostering its internationalisation process, Luiss Libera Università Internazionale degli Studi Sociali Guido Carli is pleased to invite outstanding scholars from around the world to apply for a position as a visiting professor for the 2027/2028 academic year.

The deadline for receipt of applications is 5 p.m. (CEST) on 23 October 2026.

### **General Rules**

Visiting professors at Luiss Libera Università Internazionale degli Studi Sociali Guido Carli are required to spend a minimum of 4 and a maximum of 12 consecutive weeks at the University. They are invited to conduct research with Luiss faculty, to deliver seminars and to provide teaching activities (for a minimum of 4 and up to a maximum of 16 teaching hours). To identify potential teaching activities, please check the full list of Academic Areas covered at Luiss Libera Università Internazionale degli Studi Sociali Guido Carli, through the dedicated link.

Luiss Libera Università Internazionale degli Studi Sociali Guido Carli will provide a lump sum compensation (all-inclusive and subject to taxation) to cover travel and living expenses for the duration of the visiting period. This payment will also cover a moderate teaching involvement in Luiss classes (minimum of 4 and maximum of 16 teaching hours). The envisaged gross compensation normally ranges from a minimum of €4,000 to a maximum of €6,000 per month.

### **Applications**

Candidates may apply for positions at any one of the following departments:

- Accounting and Corporate Finance
- AI, Data and Decision Sciences
- Business and Economics Law
- Business and Management
- Economics and Financial Markets
- Law and Institutions
- Political Science

Applications must be completed and submitted via the online Application Form.

In addition to general information, applicants are kindly requested to upload their CV, provide a short description of the proposed research activity to be carried out during the visiting period, and indicate a host faculty member at Luiss Libera Università Internazionale degli Studi Sociali Guido Carli. Applicants will also have to select the Academic Area for the intended teaching activity on the application form.

**The deadline for receipt of applications is 5 p.m. (CEST) on Friday 23 October 2026.**

### **Selection Criteria and Outcomes**

Selection will be carried out through dedicated academic committees within each department.

Committees, at their sole and absolute discretion, will evaluate applications taking into consideration:

- the candidate's CV;
- the proposed research activity, with a specific focus on the compatibility between the candidate's research proposal and the research activity of the selected host faculty member at Luiss Libera Università Internazionale degli Studi Sociali Guido Carli;
- how well the candidate's profile fits the selected Academic Area.

All candidates will be notified of the results of the selection procedure by 18 December 2026, via e-mail from [facultymobility@luiss.it](mailto:facultymobility@luiss.it).

### **Important Deadlines and Visiting Periods**

- 23 October 2026 (5 p.m. CEST): deadline for receipt of applications
- By 18 December 2026: notification of results
- Visiting periods will take place in one of the following terms:
  - Fall Term: 6 September 2027 – 10 December 2027
  - Spring Term: 10 January 2028 – 12 May 2028
